April Fees

Last Class for Storybook Ballet

A reminder that the last Storybook Ballet class will be held on **Saturday, June 1**, there will be in-person parent viewing on this date. The <u>last</u> monthly fee payment for Storybook ballet will be due on **May 1, 2024**.

2024 YEAR-END PERFORMANCE - "THE SNOW QUEEN"

Our year-end performance of "*The Snow Queen*" will take place at the end of May at the *university theatre* in the *University of Calgary*.

The performance will involve all students currently registered in the school except for students in our *Storybook Ballet and Adult classes*. Our rehearsal day at the theatre is booked for **Thursday May 23** (rehearsals will take place throughout the day with a dress rehearsal starting at 6.00pm, so please be aware that some school will have to be missed). There will be <u>2</u> performances, one on **Friday May 24** and the second performance on **Saturday May 25** both starting at 6.00pm.

Year-End Performance Fees & Consent Forms

At the beginning of March, all students in participating classes received a **performance consent form** by e-mail; this form should now have been completed, signed and returned with the correct performance fee to Miss Julie. The performance fee helps cover the cost of renting the theatre for 3 days and includes a student's costume rental fee. By returning the completed form and performance fee, you are confirming your child's participation in the year-end performance. If you have <u>NOT</u> yet returned your consent form, then please do so **as soon as possible** as Miss Julie needs to know *immediately* of anyone unable to participate in the performance. This is <u>very</u> important as choreography and organization of costumes is already well underway. <u>N.B.</u>

Students should only attend on the days that they are needed (please refer to the lists above). Younger students in *Pre-Primary, Primary and Grade 1 Ballet, Beginner Tap/Jazz, Primary Tap/Jazz, Jr. Hip-Hop Group A and Beginner Acro.* will <u>not</u> be expected to stay for the full rehearsal and parents should arrange to pick them up at **6.00pm**. <u>ALL</u> other students will be expected to be in attendance from **4.30pm** to **7.00pm** and we would recommend that they bring something non-messy to eat and drink and a quiet activity for when they are not dancing. Rehearsals and Dress Rehearsal at the University Theatre - Thursday, May 23

A reminder that on **Thursday, May 23** we will be holding rehearsals *throughout* the day at the **university theatre** (therefore students will have to miss some school) followed by a full dress rehearsal starting at *6.00pm*. The **senior ballet students** (i.e. Inter. Fdn. Ballet and higher) will be at the theatre in the morning on **Thursday, May 23** until the end of dress rehearsal. All other students will be required to be at the theatre for afternoon spacing rehearsals <u>and</u> the dress rehearsal (a detailed schedule for the full day of rehearsals will be in the May newsletter). Students should make sure that they have brought plenty to eat and drink to the theatre with them as well as homework and other quiet activities to keep them occupied while they are not rehearsing. *A reminder that cell phones or ipads/laptops will be allowed in the dressing rooms for entertainment and homework purposes <u>ONLY</u>, the use of social media and taking photos/videos in the dressing rooms is strictly forbidden and will be closely monitored by parent volunteers and teachers.*

Miss Julie is still confirming the rehearsal schedule for **Thursday, May 23**, so should there be any concerns regarding students missing school, then please let Miss Julie know *as soon as possible* so she can address them, she appreciates that it is a busy time of year for everybody. Thank you!

Costumes

Tickets for the Year-End Performance

Tickets for both performances will be available for purchase online starting **April 15**. Details on how to purchase tickets online will be emailed to families once the tickets are released. The price of advance tickets purchased online is **\$26.00** for general admission i.e. adults, children, students and seniors are all the same price (GST is included in this price). Tickets can also be purchased on both performance days prior to the performance at the box-office; box-office tickets cost **\$28.00**. There is no limit on the number of tickets purchased per family and the students would appreciate a large and enthusiastic audience to perform for.

Our photo day for the year-end performance will take place on **Saturday May 11** in the dance studio at the Rosedale community centre in the afternoon and evening. Cory Harding will be coming to take group and individual photos of the dancers in their costumes. Information on how to order photos online will be emailed to parents.
